Increase energy efficiency in low income houses - Good practice case in Cyprus, from the ELIH MED project



In the context of the implementation of the project ELIH MED in Cyprus, measures have been taken towards the increase of energy efficiency in 25 residential households of low income consumers. The interventions are co-financed 85% by the European Regional Development Fund of the European Union and 15% of the

COP21 – Paris 2015: Call for contributions to the Islands declaration on Climate change



The Region of Réunion launched during the 1st international conference on Climate and Energy: "Islands and Climate change: opportunity, resilience and adaptation" on 24, 25 and 26 June 2014, the initiative of a joint document to support the voice of the islands at the COP21, the Conference of the Parties to the United Nations

Framework Convention on Climate Change (COP21 / CMP11) to be held in Paris from 30 November to 1 December 2015. COP 21 is a crucial deadline that should adopt a universal binding agreement for transition to a low-carbon economy and limiting global warming to below 2°C. Read more

Development of renewables energies projects in Scotland: involving local communities is a key to success



After the promising "Our islands, our future campaign" and in their path towards a more sustainable future, Scottish islands are still facing barriers to reduce fuel poverty, to increase energy efficiency in housing. During the Highland Council's second Carbon Clever Conference in Inverness on 17th November, councilors debated especially on drastic measures that are needed to increase energy efficiency in housing. Concrete and effective community-led initiatives where local communities draw their supplies from small local schemes are the key to success.

The local community was invited to find out more about <u>Kyle Rhea – Sea generation</u> project. Scottish Power Renewables is to construct an <u>offshore demonstration tidal energy array in the Sound of Islay</u>. And while the <u>largest community owned windfarm</u> in Scotland generates revenues, the <u>Ardchonnel 15 turbines</u> wind farm project was rejected. A <u>new hybrid ferry</u> was launched in Lochinvar, the use of an <u>Electric car Nissan Leaf and a Hybrid minibus</u> are benefiting communities in the Isle of Mull, an exemplary island where the community-led <u>Garmony Hydro</u> project is progressing.

Members of the Estonian SMILEGOV cluster are participating in the national mentoring program for energy cooperatives



In November 2014 Estonian Development Fund started mentoring program for the initiatives of energy cooperatives. 10 participants all over Estonian were chosen, including 4 initiatives from SMILEGOV cluster islands Saaremaa, Ruhnu and Hiiumaa. Read more

The Wind-Hydro-Pumped Station of El Hierro has been successfully inaugurated last June 27th, with the participation of politicians and technicians involved in the project. EU Council conclusions on 2030 Climate & Energy Policy, the EU step towards COP21


